**ARTICLES OF ORGANIZATION FOR
S & G FLORIDA, LLC.
A FLORIDA LIMITED LIABILITY COMPANY**

The undersigned, desiring to form a limited liability company under and pursuant to Florida Statute, Section 608.401 et. seq., entitled the Florida Limited Liability Company Act, does hereby adopt the following Articles of Organization for such company:

1. **NAME.** The name of this company shall be S & G FLORIDA, L.L.C.
2. The address of the principal office of the Company is 4875 North Federal Highway, 7th Floor, Fort Lauderdale, Florida 33308.
3. **REGISTERED AGENT AND OFFICE.** The name and street address of the initial registered agent and office for the Company is as follows: ARTHUR R. ROSENBERG, located at 4875 North Federal Highway, 7th Floor, Fort Lauderdale, Florida 33308.
4. **MANAGEMENT OF THE COMPANY.** The business of the Company shall be managed by Michael Sorotzkin, the Managing Member of the Company, whose address is 4875 North Federal Highway, 7th Floor, Fort Lauderdale, Florida 33308 or such other managers as may be appointed by the members in accordance with the provisions of the Operating Agreement.


