**ARTICLES OF ORGANIZATION FOR

The undersigned, desiring to form a limited liability company under and pursuant to Florida Statute, Section 608.401 et. seq., entitled the Florida Limited Liability Company Act, does hereby adopt the following Articles of Organization for such company:

1. **NAME.** The name of this company shall be **LIQUID PUBLISHING, LLC.**
2. **ADDRESS OF COMPANY.** The mailing and street address of the principal office of the Company is **1600 NE 205th Terrace, North Miami Beach, Florida 33179.**

4. **MANAGEMENT OF THE COMPANY.** The business of the Company shall be member managed by **LOD ADRENALINA, LLC.**, a Florida limited liability company, or such other member as may be appointed by the members in accordance with the provisions of the Operating Agreement.


