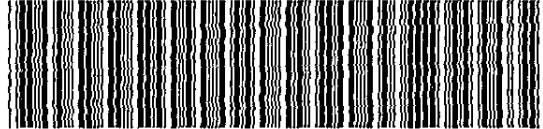

ARTICLE I

NAME

The name of this limited liability company is RTC ENTERPRISES OF S.W. FLORIDA, LLC, referred to in these Articles of Organization as the "Company."

ARTICLE II

PRINCIPAL OFFICE AND REGISTERED AGENT
