

ARTICLES OF ORGANIZATION OF RTC ENTERPRISES OF S.W. FLORIDA, LLC, A FLORIDA LIMITED LIABILITY COMPANY

The undersigned, as a member of the Company, hereby certifies that:

STATE OF THE STATE

ARTICLE I

NAME

The name of this limited liability company is RTC ENTERPRISES OF S.W. FLORIDA, LLC, referred to in these Articles of Organization as the "Company."
