

ARTICLES OF ORGANIZATION PHOENIX CONSTRUCTION, LLC

OS WILLS ON THE SECOND The undersigned, for the purpose of forming a multi member limited liability company Florida Limited Liability Company Act, F.S. Chapter 608, does hereby make, acknowledge, and following Articles of Organization.
