

The name of the limited liability company shall be BFNBLT INVESTMENTS, L.L.C. ("company").


**ARTICLE II — ADDRESS**

**ARTICLE IV — MANAGEMENT**



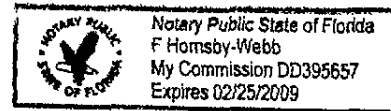
