ARTICLES OF ORGANIZATION

OF

WATSON'S FISH CAMP PROPERTIES, LLC

a Florida Limited Liability Company

ARTICLE I NAME

The name of this Limited Liability Company is:

WATSON'S FISH CAMP PROPERTIES, LLC (the "Company").

ARTICLE II PURPOSE

- A. <u>Member Voting.</u> All members of the Company shall be entitled to vote on matters relating to the Company. Each Member's vote shall be weighted in accordance with the Regulations of the Company.
- B. <u>Additional Contributions.</u> The Members shall make additional capital contributions from time to time, as required by the Regulations adopted by the Company.

The Members may from time to time, without amending these Articles, move the registered office to any other address within the State of Florida.
