ARTICLES OF ORGANIZATION

OF

FIREHOUSE RED PAINTING, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be FIREHOUSE RED PAINTING, LLC, ("Company").

ARTICLE 2 - ADDRESS

The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.
