
**Article Six**

A Manager of this company shall not be personally liable to the company or its Members for monetary damages for breach of fiduciary duty as a Manager, except for the liability (a) for a breach of the Manager's duty of loyalty to the company or its Members, (b) for acts or omissions not in good faith or which involve intentional misconduct or knowing violation of law, (c) for a transaction from which the Manager derived an improper personal benefit, or (d) under Section 608.4363(7), FS (or any similar provision of any subsequent law enacted in Florida).

Each individual or entity who is or was a Manager of the company (and the heirs, executor, personal representatives, administrators, successors or assigns of such individual or entity) who was or is made a party to, or is involved in any threatened, pending or completed action, suit or proceeding, whether civil, criminal, administrative, investigative, by reason of the fact that such person is or was a Manager of the company ("indemnitee"), shall be indemnified and held harmless by the company to the fullest extent permitted by applicable law, as the same exists or may hereafter be amended. In addition to the indemnification conferred in this Article, the Indemnitee shall also be entitled to have directly by the company the expenses reasonably incurred in defending any such proceeding against such Indemnitee in advance of its final disposition, to the fullest extent authorized by applicable law, as the same exists or may hereafter be amended. The company may, by action of the Manager, provide indemnification to such of the officers, employees and agents of the company to such extent and to such effect as the Manager shall determine to be appropriate and authorize by applicable law. The rights and authority conferred in this Article shall not be exclusive of any other right which any person may have or hereafter acquire under any statute, provision of the Articles of Organization or Regulations of the company, agreement, vote of Members or otherwise. Any repeal or amendment of this Article by the Members of the company shall not adversely affect any right or protection of a Manager or officer existing at the time of such repeal or amendment.

- Article Seven** No Member of the company shall be an agent of the company solely by virtue of being a Member, and no Member shall have authority to incur debt or contractual liability on behalf of the Company solely by virtue of being a Member.
- Article Eight** These Articles of Organization may be amended or repealed upon the approval of then existing Members of the company.
- Article Nine** The company shall adopt regulations for the company, which regulations may contain any provisions for the regulation and management of the business and affairs of the company not inconsistent with these Articles of Organization, or Chapter 508, FS.
