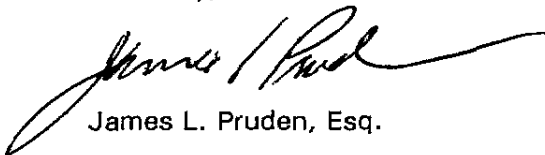

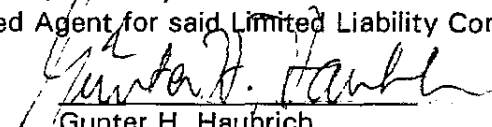

ARTICLE VI – MANAGEMENT

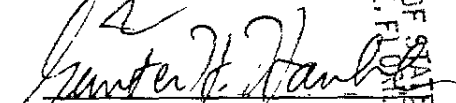
