ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF NE-PALMETTO, L.L.C. (A Florida Limited Liability Company)

FIRST:

The date of filing of the Articles of Organization was August 1, 2005.

SECOND: Article II of the Company's Articles of Organization is hereby deleted in its entirety and replaced with the following:

ARTICLE II NAME AND PRINCIPAL PLACE OF BUSINESS
