Hameed.**

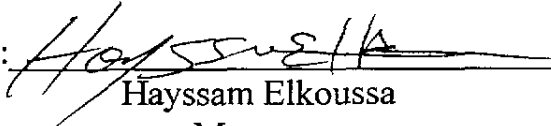
SECOND: Article VI -- *Management of Company* is amended by deleting the last sentence in this Article VI and replacing it with the following:
