#### ARTICLES OF ORGANIZATION

#### **FOR**

#### CIRCLE C PROPERTIES, LLC

The undersigned member hereby certifies to the following in order to form a Limited Liability Company under Chapter 608, Florida Statutes.

#### ARTICLE I - NAME

The name of the Limited Liability Company is CIRCLE C PROPERTIES, LLC.

#### **ARTICLE II - DURATION**
