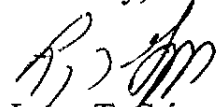

ARTICLES OF ORGANIZATION
OF
VILANO ENTERPRISES, LLC

ARTICLE I

The name of the limited liability company ("Company") is VILANO ENTERPRISES, LLC.

ARTICLE II

The mailing address and principal address of the Company is 72 Leidel Drive, Palm Coast, Florida 32137.

ARTICLE III

The name of Company's initial registered agent in Florida is Marilyn Michelle Lindsey. The address of Company's registered office in Florida is 72 Leidel Drive, Palm Coast, Florida 32137.

ARTICLE IV

The Company is a manager-managed company. Its manager is Marilyn Michelle Lindsey, 72 Leidel Drive, Palm Coast, Florida 32137 who shall serve until she resigns or her successor is elected.

ARTICLE V

Members of the Company have the right to admit new members. Additional members may be admitted only on the unanimous written consent of the existing members, and the existing members shall determine the amount and nature of contributions by new members at the time the new members are admitted.

ARTICLE VI

The remaining members of the Company have the right to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company. The business may be continued only on the unanimous written consent of the remaining members.

ARTICLE VII

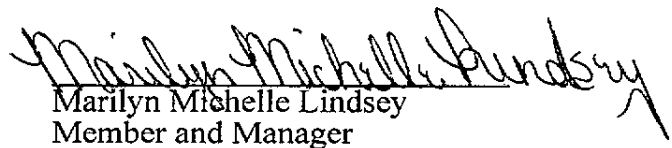
To the greatest extent not inconsistent with the laws and public policies of Florida the Company will indemnify, as a matter of right, any Member made a party to any proceeding because he or she is or was a Member, against all liability incurred by such individuals in connection with any proceeding; provided that such individual has met the standard of conduct for indemnification set forth under Florida law.

ARTICLE VIII

Additional Provisions

The power to adopt, alter, amend or repeal the regulations of the Company is vested entirely in the members.

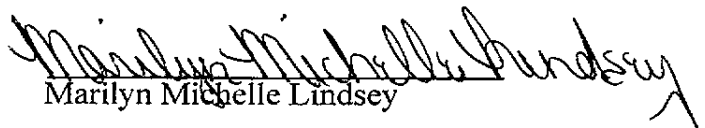
