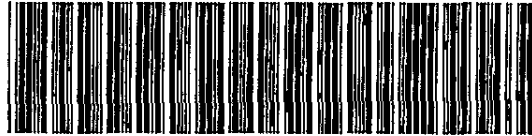



ARTICLES OF ORGANIZATION

OF

A LUCKY SPINNERS, L.L.C.

ARTICLE I - NAME

THE NAME OF THIS Limited Liability Company shall be **A LUCKY SPINNERS, L.L.C.**

ARTICLE II - ADDRESS
