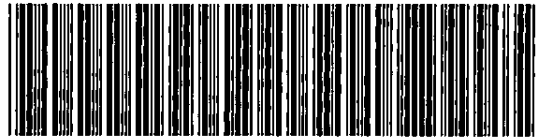




Upon unanimous vote of all members, the name of the above organization is changed to:

SMITHWELL MAINTENANCE, LLC.


