**ARTICLES OF ORGANIZATION FOR
FLORIDA LIMITED LIABILITY COMPANY**

The undersigned authorized representatives, desiring to form a limited liability company pursuant to the provisions of the Florida Limited Liability Company Act, hereby submits, and files with the Florida Department of State, these Articles of Organization.

ARTICLE I - Name

The initial members of the Company and their ownership interest therein shall be as set forth in the Operating Agreement of the Company.


ARTICLE VIII - Admission of Additional Members
