**ARTICLES OF ORGANIZATION FOR
FLORIDA LIMITED LIABILITY COMPANY**

The undersigned authorized representative, desiring to form a limited liability company pursuant to the provisions of the Florida Limited Liability Company Act, hereby submits, and files with the Florida Department of State, these Articles of Organization.

ARTICLE I - Name

The name of the limited liability company created hereby ("the Company") is: **SOUTHERN PRO'S, LLC**

The total number of membership units authorized to be issued by the Company shall be 10,000 units. Each of the said units shall entitle the holder thereof to one (1) vote at any meeting of the members. All membership units then issued shall be paid for and shall be nonassessable.

The initial members of the Company and their ownership interest therein shall be as set forth in the Operating Agreement of the Company.


ARTICLE VIII - Admission of Additional Members
