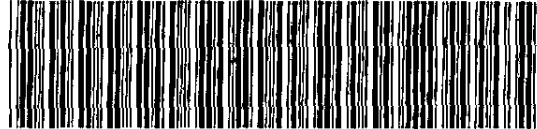

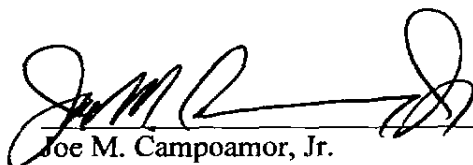

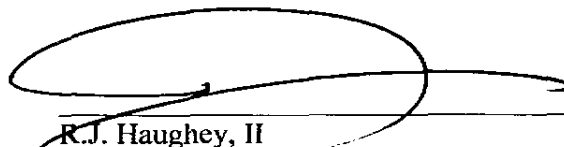
**CERTIFICATE DESIGNATING
