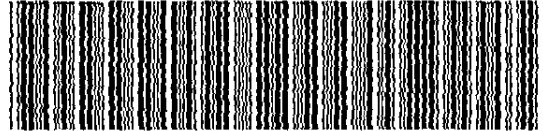

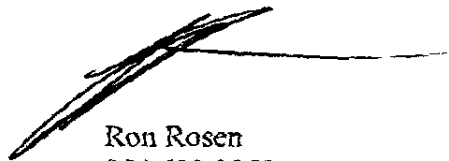

4. The following Articles are hereby added to the Articles of Organization:

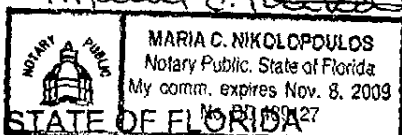
ARTICLE VI - Assignment of Membership Interest

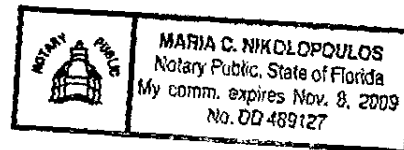
