**ARTICLES OF ORGANIZATION
OF
LAKE CARROLL ESTATES OF TAMPA, LLC**

The undersigned person, acting as the organizer of LAKE CARROLL ESTATES OF TAMPA, LLC, under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, adopts the following Articles of Organization:
