

ARTICLES OF ORGANIZATION MM 350 NW LLC, A FLORIDA LIMITED LIABILITY CORPORATION

The undersigned, being a duly authorized representative of a member, desiring to form a liability company under r 608, Florida Statutes, does hereby adopt the rome.

ARTICLE I. NAME

The name of the limited liability company is MM 350 NW LLC (the "Company"). ARTICLE VII. OPERATING AGREEMENT

The power to adopt, alter, amend, or repeal the Operating Agreement of the Company shall be vested in the Members of the Company.
