

ARTICLES OF ORGANIZATION FOR RONDO'S, LLC A FLORIDA LIMITED LIABILITY COMPANY



ARTICLE I.

The name of the Limited Liability Company is "Rondo's, LLC" (the "Company").

ARTICLE II. ADDRESS
