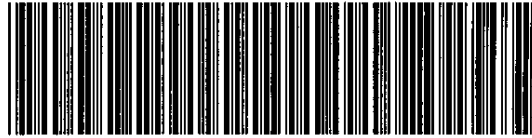



TO HAVE AND TO HOLD the same unto the said parties of the second part forever.


