ARTICLES OF ORGANIZATION OF

ATWATER, LLC

A Florida Manager-Managed Limited Liability Company

The undersigned Member does hereby execute these Articles of Organization for the purpose of organizing a Florida Limited Liability Company, pursuant to Chapter 608 of the Florida Statutes:

- Name. The name of the Company is ATWATER, LLC (the "Company").
- 2. **Mailing and Street Address**. The mailing and street address of the Company's principal place of business shall be 7700 High Ridge Road, Boynton Beach, Florida 33426, but it shall have the power and authority to establish branch offices at such place or places as may be designated by the members.
- Principal Office. The principal place of business for the Company shall be 1700 High Ridge Road, Boynton Beach, Florida.
- 4. Duration. The Company shall exist from the date of filling these Articles with the Florida Department of State, or the later occurrence of any of the termination events specified in Florida Statue §608.441, or as may be provided in the Operating Agreement adopted by the Members, and its existence shall otherwise be perpetual.
- Registered Agent and Office. The name and address of the registered agent of the Company is Joel T. Strawn, Esq., 54 N. E. Fourth Avenue, Delray Beach, Florica 33483.
- 6. Management. The Company shall be a manager-managed company, within the meaning of 608.402 (19), and initially shall be managed by the following person who shall serve as manager until the first annual meeting of the members or until his successor(s) is/are elected and qualify, as provided in the Operating Agreement: Harold D. Kilpatrick, Sr.
- 7. Additional Members. Additional members of the Company may be admitted as provided in the Operating Agreement.
- 8. **Termination of Membership.** If a member of the Company dies, retires coigns, is terminated, its entity is dissolved, experiences bankruptcy or upon the occurrence of the country of the country of the company, the remaining members may continue the business of the Company.
- 9. Indemnification. To the maximum extent permitted by law, the Company shall idemnify any person who was or is a party to any proceeding by reason of the fact that he he is or was a manager, managing member or officer of the Company or is or was selling at the request of the Company as a manager, managing member, director or officer of another limited liability company, corporation, partnership, joint venture, trust or other enterprise against liability incurred in a manner he/she reasonably believed to be in, or not opposed to, the best interests of the Company and, with respect to any criminal action or proceeding, had no reasonable cause to believe his/her conduct was unlawful. The Company shall reimburse each person for all costs and expenses, including, without limitation, attorneys'

fees, reasonably incurred by him/her in connection with any such liability in the manner provided for by law or in accordance with the regulations of the Company. The rights accruing to any person under the foregoing provision shall not exclude any other right to which he/she may be lawfully entitled, nor shall anything therein contain or restrict the right of the Company to indemnify or reimburse such person in any proper case even hough not specifically provided for herein.
