

## ARTICLES OF ORGANIZATION OF THE ABYSS, L.L.C.

The undersigned, acting as Organizers of a Florida Limited Liability Company under the Florida Limited Liability Company's Act, Chapter 608 of the Florida Statutes, hereby adopts the following Articles of Organization for such Limited Liability Company.

### **ARTICLE I**

#### <u>NAME</u>

The name of the Limited Liability Company is THE ABYSS, L.L.C.

### **ARTICLE II**

### DURATION

The Limited Liability Company shall be perpetual from the date of filing these Air Organization with the Department of State.

### ARTICLE VIII

### MANAGEMENT AND OWNERSHIP INTEREST

The Limited Liability Company is to be managed by one manager who must be a member and is, therefore, a manager-managed company. The initial member-manager ANGELA HELMS,

### ARTICLE IX ADOPTION OF REGULATIONS

Regulations governing the Limited Liability Company will be adopted, modified, amended or rescinded only upon a majority of the members.

### ARTICLE X AMENDMENTS TO ARTICLES OF ORGANIZATION

These Articles of Organization may be amended, modified, or rescinded only upon a unanimous vote of the members.
