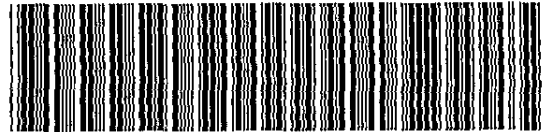

**ARTICLES OF ORGANIZATION
OF
ION PROPERTIES, L.L.C.**

The undersigned hereby certify that we have associated ourselves together for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges and immunities of limited liability companies for profit and hereby adopt the following Articles of Organization for such limited liability company:

**ARTICLE I
NAME AND PRINCIPAL OFFICE**

The name of this limited liability company is ION PROPERTIES, L.L.C., and its principal office is located at 226 Cherokee Road, Ormond Beach, Florida, Volusia County, Florida 32174, and its mailing address is P.O. Box 12188, Daytona Beach, Volusia County, Florida 32120.

**ARTICLE II
DURATION**

The existence of this limited liability company shall be perpetual, commencing upon the filing of the Articles of Organization by the Florida Department of State.

**ARTICLE III
PURPOSE**

The purpose of this limited liability company is to engage in any activity or business permitted under the laws of the United States and the State of Florida.

**ARTICLE IV
DISSOLUTION**

The limited liability company will dissolve as provided in the Operating Agreement executed by and among its members.

**ARTICLE V
MANAGEMENT**

This organization is to be managed by a manager or managers elected by a majority vote of

its members. The initial manager, who shall serve until the earlier of their death, resignation, replacement or until the first annual meeting of members and her successor is elected and qualified, shall be PATRICIA A. HOFFMAN.

**ARTICLE VI
INITIAL REGISTERED OFFICE AND AGENT**

The initial registered office of this limited liability company shall be located at 226 Cherokee Road, Ormond Beach, Florida, Volusia County, Florida 32174, and the initial registered agent of the limited liability company at that address shall be PATRICIA A. HOFFMAN.
