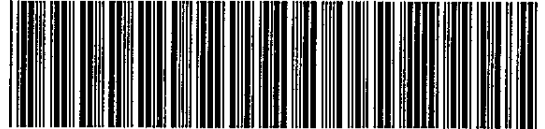

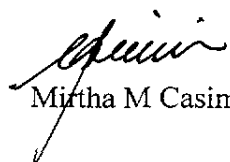

Each member shall make additional capital contributions to the Company only upon the unanimous consent of all the members.

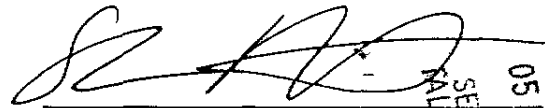

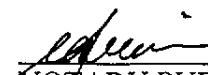
