## ARTICLES OF ORGANIZATION

### COURTSIDE AT MISSION BAY, LLC

ARTICLE I - Name: The name of the Limited Liability Company shall be COURTSIDE AT MISSION BAY, LLC.

ARTICLE VII - Members Rights to Continue of Business: The remaining members the limited liability company will have to continue the business on death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a the limited liability company, member in subject to such provisions governing such event as may be set forth in any applicable Operating Agreement.

ARTICLE VIII- Applicable Regulations: If
