The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, <u>Florida Statutes</u>, Chapter 608, hereby make, acknowledge and file the following Articles of Organization.

#### ARTICLE I - NAME

The name of the limited liability company shall be: TS & J, LLC.

#### ARTICLE II - ADDRESS

The street address of the principal office and mailing address of this Company is 5816 Oakmont Lane, Lakeland, FL 33813.

### ARTICLE III - DURATION
