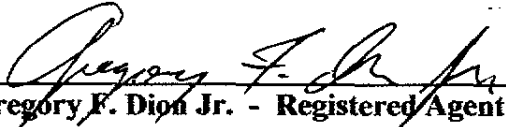

A departing member, or the estate of the deceased or bankrupt member, shall be compensated in cash for the membership interest of such member in an amount equal to the member's outstanding capital contribution plus the member's proportionate share of any accrued net Company profits, or less the member's proportionate share of any accrued net Company losses. Company assets shall be valued at book value for

purposes of this provision, with no value attributed to goodwill.

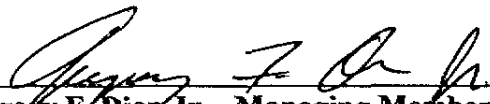

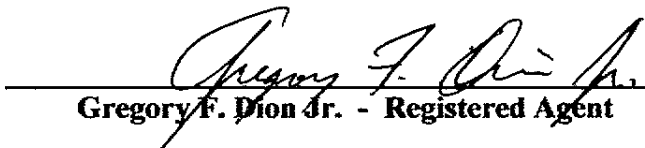

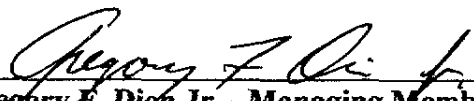
