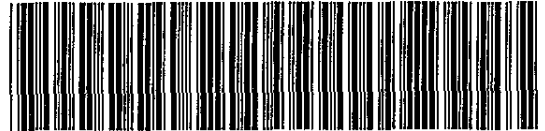

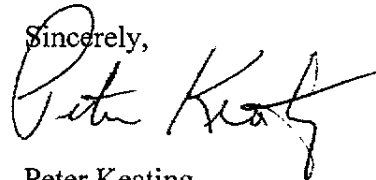

ARTICLES OF ORGANIZATION OF JAX' EVENTS, L.L.C

The undersigned certify that we have associated ourselves together for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit. We further declare that the following Articles shall serve as the Charter and authority for the conduct of business of the limited liability company.

ARTICLE I.

NAME OF LIMITED LIABILITY COMPANY

ARTICLE II.

PRINCIPAL PLACE OF BUSINESS

CAPITAL CONTRIBUTIONS

Capital contributions in the amount of \$500.00 cash shall be paid to the limited liability company by the members at a percentage rate of 85% from Stacy Evens and 15% from Jennifer Hefner in regards to shares. Additional contributions will be made as required for investment purposes, at the same percentage rates.

ARTICLE VI.


PROFIT AND LOSSES

(a) *Profit Sharing.* The members shall be entitled to the net profits arising from the operation of the limited liability company business that remain after the payment of the expenses of conducting the business of the limited liability company. Stacy Evens shall be entitled to 85% and Jennifer Hefner shall be entitled to 15% in regards to distributive share of the profits.

(b) *Losses.* All losses that occur in the operation of the limited liability company business shall

be paid out of the capital of the limited liability company and the profits of the business, or, if these sources are insufficient to cover such losses, they remaining coverage of such losses shall be paid at a rate of 85% by Stacy Evens and 15% by Jennifer Hefner.
