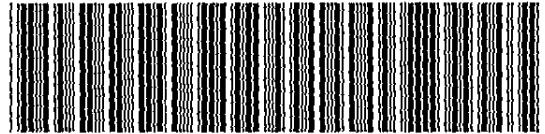

**ARTICLE I. NAME OF LIMITED LIABILITY COMPANY**

The LLC has the authority and shall issue Certificates of Membership to each Member evidencing that Member's interest in the LLC. Certificates of Membership.


