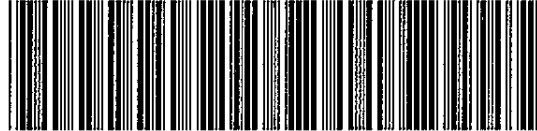

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

**ARTICLE I -- NAME**

The name of the limited liability company shall be DONEGAL PARTNERS, L.L.C. ("company").

**ARTICLE II -- ADDRESS**

The mailing address and street address of the principal office of the company is 2345 Highway A1A, Vero Beach, Florida 32963.

**ARTICLE III -- DURATION**

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State or on another effective date if specified. The company's existence shall be perpetual unless the company is dissolved earlier as provided in these articles of organization or in the regulations.

**ARTICLE IV -- REGISTERED OFFICE AND AGENT**

**ARTICLE V -- MANAGEMENT**

The Company shall be managed by one or more Managing Members elected from time to time by the members. Only Members of the Company shall be eligible for election as a Managing Member. Except as otherwise provided in this Operating Agreement, each Managing Member shall have the right to act for and bind the Company in the order course of business; provided, however, if there is disagreement among the Managing Members as to any issue of management of the Company, the decisions of a majority in interest in the profits of the Company owned by the Managing Members shall control.

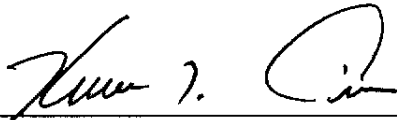

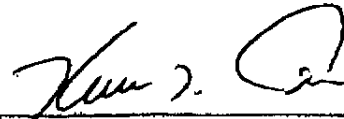
