Pursuant to the provisions of Section 608.441, of the Florida Limited Liability Company Act, SABLE PALMS, LLC, a Florida limited liability company (the "Company"), hereby files the following Articles of Dissolution for the purpose of dissolving the Company:

1. The name of the Company is SABLE PALMS, LLC.
2. The filing date of the Articles of Organization was August 12, 2005, under Document No. L05000080058.
3. The dissolution was authorized and approved by Masmar Investments, LLC, a Florida limited liability company ("Masmar") which is the sole Member of the Company by written consent dated July 27, 2009, which is sufficient for the dissolution of the Company.
4. Masmar as the sole Member has made adequate provisions for all debts, obligations and liabilities of the Company, including the distribution of all *remaining* property and assets to the Member in accordance with his rights and interests.

In accordance with Section 608.446 of the Florida Limited Liability Company Act, the dissolution of the Company shall be effective upon filing of these Articles of Dissolution with the Florida Department of State.
