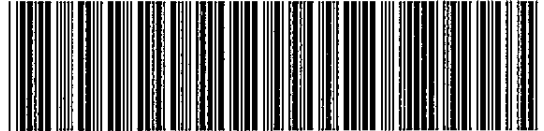

ARTICLE I – Name:
