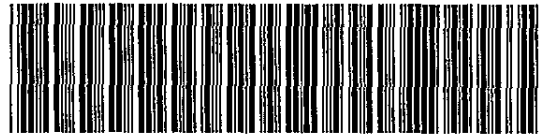




ARTICLE V
