

ARTICLES OF ORGANIZATION

ASCENTIAL SHAPE SEABOARD LENDING GROUP, LLC, a Florida Limited Liabilit

ARTICLE I- NAME

The name of the limited liability company shall be SEABOARD LENDING GROUP, LLC, a Florida Limited Liability Company, LLC (hereinafter referred to as the "Company").

ARTICLE VI- ADMISSION OF NEW MEMBERS
