**ARTICLES OF ORGANIZATION

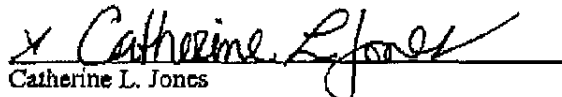
