**ARTICLES OF ORGANIZATION
OF
P3L, LLC**

The undersigned authorized representative of a member of the captioned Limited Liability Company, under the provisions of the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, adopts the following Articles of Organization:

ARTICLE I

Name, Mailing Address and Purpose of Organization

The name of this limited liability company is P3L, LLC (the "Company"). The Company's principal address and mailing address is 7707 Nature Trail, Lakeland, Florida, 33809. 
