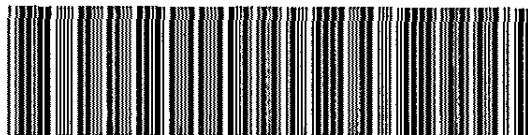

ARTICLES OF ORGANIZATION
OF
HILINE MOTOR SPORTS, L.L.C.

The undersigned for the purpose of forming a limited liability company under the Florida Limited Liability Company Act hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I-NAME

The name of the limited liability company shall be Hiline Motor Sports, L.L.C. ("Company"). The principal place of business of the Company in Florida shall be Suite 306, 8300 S.W. 8th. St., Miami, Fl. 33144.

ARTICLE II-PURPOSES AND POWERS

ARTICLE IV-ADMISSION OF NEW MEMBERS

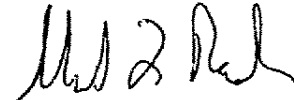

ARTICLE V-MANAGEMENT

The Company shall be managed by one manager in accordance with regulations adopted by the members for the management of the business and affairs of the Company. These regulations may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization.

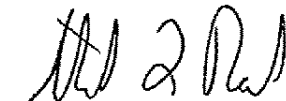
