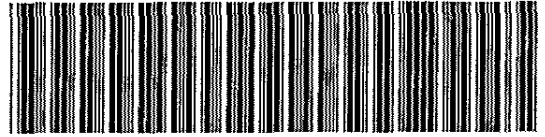

#### **ARTICLE VI - Admission of Additional Members**

A new member may be admitted to the Company only with written consent of all existing members. A member may retire from the Company by delivering sixty (60) days prior written notice of such retirement to the manager and to each other member. A member may be expelled from the Company only for cause and only upon the unanimous vote of all the members. Cause include a willful and substantial breach to this Agreement, bankruptcy of a member, and conduct prejudicial to the Company and its members. A retiring, bankrupt, or expelled member shall be compensated for his/her interest in the Company.

#### **ARTICLE VII - Members Rights to Continue Business**

The right, if given, of the remaining members of the Limited Liability Company to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member shall be given if within thirty (30) days from the date of the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member, the remaining members, by a majority vote, have voted to continue the operation of the Company. A departing member, or the estate of the deceased or bankrupt member, shall be compensated in cash for the membership interest of such member in an amount equal to the member's outstanding capital contribution plus the member's proportionate share of any accrued net Company profits, or less the member's proportionate share of any accrued net Company losses. Company assets shall be valued at book value for purposes of this provision, with no valued attributed to goodwill.

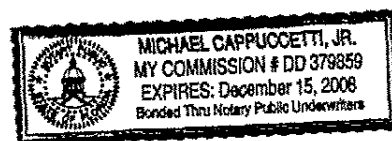
