**ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF
BA-WRIGHT PROPERTY DEVELOPMENT, LLC**

Article V of the Articles of Organization of **BA-WRIGHT PROPERTY DEVELOPMENT, LLC**, was amended by the limited liability company's Managing Members on October 24, 2005. The limited liability company is filing these Articles of Amendment to Articles of Organization pursuant to Florida Statutes Section 608.

1. The name of the limited liability company is **BA-WRIGHT PROPERTY DEVELOPMENT, LLC**.
2. The Articles of Organization were filed with the Florida Department of State on August 15, 2005.
3. Article V of the Articles of Organization of the Corporation shall be amended to read as follows:

ARTICLE V

The remaining Member(s) of the Company may continue the business upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the Company upon agreement as provided in the Operating Agreement of the Company."

4. The foregoing amendment to the Articles of Organization was voted on by the Members of the limited liability company entitled to vote on the matter and the number of votes cast by the Members was sufficient for approval.
