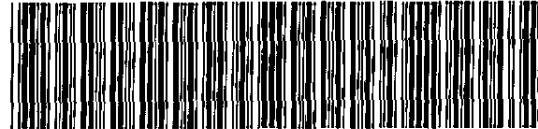

The mailing address and street address of the principal office of the company is 100 Bramblewood Drive, Safety Harbor, Florida, 33695.


**ARTICLE III -- DURATION**
