Article I. Name

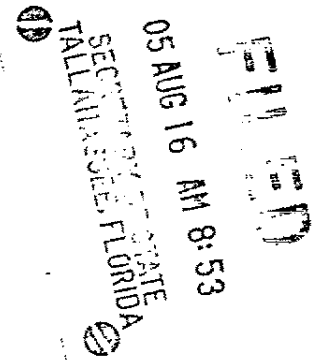

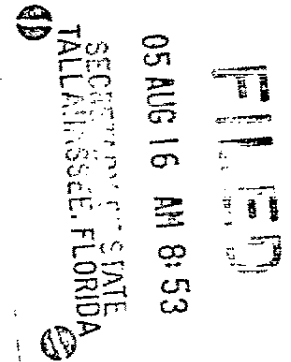

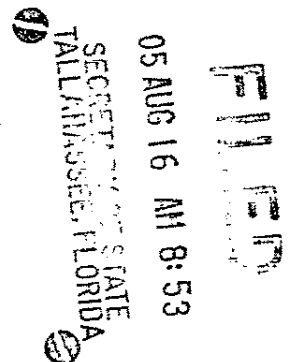
