

**ARTICLES OF ORGANIZATION
OF
MANDARIN EQUINE VETERINARY SERVICES, LLC**

The undersigned individual hereby adopts these Articles of Organization in order to form a limited liability company under Chapter 608, Florida Statutes.

**ARTICLE I
NAME**
