### ARTICLES OF ORGANIZATION MM YMCA VILLAGE ALLAPATTAH PHASE I, LLC A FLORIDA LIMITED LIABILITY CORPORATION

The undersigned, being a duly authorized representative of a member, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:
