# ARTICLES OF ORGANIZATION

OF

# CUVAL LLC, a Florida limited liability company

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a limited liability company under the laws of the State of Florida set forth the following:

# ARTICLE I: NAME

The name of the limited liability company is Cuval LLC, a Florida limited liability company (the "Company").

# ARTICLE II: ADDRESS OF PLACE OF BUSINESS

The principal place of business for the Company will be c/o Raul Sanz Machado, Eq., Aveledo, Klemprer Rivas, Perez, Trujillo Sanz & Asociados, Escritorio Juridico, Torre Delta, Piso 11, Av. Francisco De. Miranda, Altamirea Sur, Caracas 1062, Venezuela.

### ARTICLE III: REGISTERED AGENT

The Company shall be a manager-managed limited liability company and shall be managed in accordance with the Operating Agreement adopted by the member(s) for the management of the business and affairs of the Company. The Operating Agreement may contain any provisions for the regulation and management of the business and operations of the Company, not inconsistent with Florida law or the Articles. The initial Manager of the Company shall be Raul Sanz Machado.

### ARTICLE VIII: AMENDMENT

The Articles may be amended only in accordance with the Operating Agreement.
