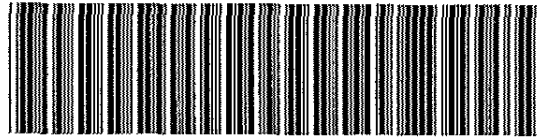

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

**ARTICLE I - NAME**

The name of the limited liability company shall be BEAR TRACK TWO, LLC ("company").

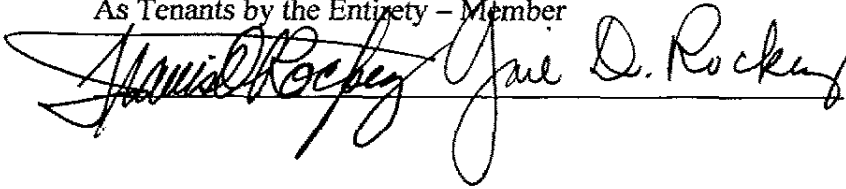
**ARTICLE VI - MANAGEMENT**

The company shall be managed by the Members.

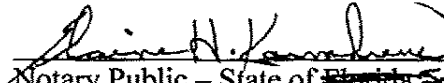
