**ARTICLES OF ORGANIZATION**

These Articles of Organization are made for the purpose of forming a limited liability company under the Florida Limited Liability Company Act (Ch. 608, Florida Statutes).

**ARTICLE I**

**NAME**

The name of this limited liability company is WILDER OAKS, LLC (the "Company").

**ARTICLE II**

**DURATION**

#### **ARTICLE IV**

##### **REGISTERED AGENT AND OFFICE**

## **ARTICLE X**


### **POWERS**
